## STUDENT AFFILIATE AGREEMENT

*Please read and agree to the following terms to become our Student Affiliate:*

### 1. Purpose of the Agreement

When a Student purchases the Course Creator's online course(s), they will automatically be assigned a **unique affiliate code** that enables them to promote the course and earn commissions under the **same terms** as influencers.

The Student Affiliate will earn a **commission for each successful sale** generated through their **affiliate link**, allowing them to **learn and earn simultaneously**.

---

### 2. Affiliate Commission Structure

#### 2.1 Standard Commission Rate

- The **standard affiliate commission** is **30%** of the marked course price for each successful purchase made through the Student Affiliate's **affiliate link**.
- Buyers who purchase via the Student Affiliate's affiliate link will receive a **10% discount** on the marked course price.

#### 2.2 Tiered Commission Increase

- If the Student Affiliate generates **100 or more course sales**, their commission rate will **increase to 40%** for future sales.

#### 2.3 Payment Method & Schedule

- Commissions are **automatically tracked and calculated** via the Course Creator's **built-in affiliate system**.
- Payments will be made via **[PayPal, Stripe, or Bank Transfer]** on a **[weekly/monthly]** basis, provided the minimum payout threshold of **[\$[Insert Amount]]** is met.

- ✓ Blogs, websites, and email marketing
- ✓ Video content, webinars, and online communities

#### 3.2 Prohibited Activities

The Student Affiliate **must NOT**:

- ✗ Use false or misleading advertising claims.
- ✗ Engage in **spam marketing** or unauthorized email promotions.
- ✗ Use their **own affiliate link** to purchase the course for personal gain.
- ✗ Promote the course in a manner that damages the Course Creator's **brand reputation**.

#### 3.3 Compliance with Laws

The Student Affiliate **must comply** with:

- ✓ **Federal Trade Commission (FTC) guidelines** on affiliate disclosures.
- ✓ **Advertising and consumer protection laws** in their respective countries.
- ✓ **Laws and regulations in Australia, the UK, the US, and other applicable jurisdictions** related to online marketing, advertising, and affiliate programs.

---

### 4. Intellectual Property Rights

- The Course Creator retains **all ownership rights** to course materials, branding, and trademarks.
- The Student Affiliate is **not permitted** to modify, resell, or claim ownership of the course content.
- The Student Affiliate may **only use approved marketing materials** provided by the Course Creator.

---

### 5. Dispute Resolution & Legal Protection

#### 5.1 Fraudulent Sales & Chargebacks

- If a sale is **disputed, refunded, or charged back**, the Course Creator reserves the right to **deduct** or **claw back** the affiliate commission from the Student Affiliate's future earnings.

## 5.2 Termination Rights

- The Course Creator may **terminate this Agreement** immediately if:
  - ✓ The Student Affiliate violates the **Prohibited Activities** (Section 3.2).
  - ✓ Fraudulent activities, misleading claims, or **violations of advertising laws** are detected.
  - ✓ The Student Affiliate **fails to generate sales** for a period of **[12 months]**.

## 5.3 Liability Limitation

- The Course Creator is **not liable** for any loss, damages, or business interruption arising from the Student Affiliate's promotions.
  - The Student Affiliate **agrees to indemnify** the Course Creator against any **legal claims or penalties** related to their marketing activities.

## 6. Confidentiality & Data Protection

- The Student Affiliate **must not disclose** any proprietary information, affiliate earnings, or commission structures to third parties.
  - Both parties agree to comply with **GDPR and other data privacy laws** regarding customer information.
- 

## 7. Agreement Duration & Termination

- This Agreement remains in effect indefinitely unless terminated by either party with written notice.
  - Upon termination, the Student Affiliate loses access to their affiliate link and any unpaid commissions.

## 8. Governing Law & Jurisdiction

- This Agreement shall be governed by and interpreted under the laws of **[VIC/Australia]**.
- The Student Affiliate agrees to comply with the laws of **Australia, the UK, the US, and any other applicable jurisdictions**.

- Any disputes shall be resolved through **binding arbitration in [VIC/Australia]** or a court of competent jurisdiction.

- This document constitutes the **entire agreement** between the parties and supersedes all prior negotiations.
